

Competition Rules

1. You can only enter this competition online at the website www.gloriousgalloway.com Details are on the Home Page.
2. Photographic entries must be digitally uploaded to the website in JPEG format, in either Portrait or Landscape in a ratio of 4:6 or 6:4. Maximum file size would be 1500 x 700 pixels.
3. Photos may be edited by the entrant i.e. may be manipulated in colour or composition (montage, collage, retouching etc.) to differ from the original. Re-sharpening and correction of the tonal value is also permitted. Everyone must register for the competition by completing the official entry.
4. A winner will be picked for each of the following categories;
a) Landscape, b) Coastal, c) Activity.
5. The image or images must be from a scene or activity that has taken place or that is part of the Galloway Region of Scotland which includes the Counties of Kirkcudbrightshire and Wigtownshire.
6. The entries must be submitted by 15th November 2011
7. Judging will be done by 3 members of the Consortium Management Team
8. The winning entries for each category will receive a £30 gift voucher, and the Overall winner will receive a prize of a 3 night break here in Galloway with all meals included .
9. Winners will be notified by email and the overall winner will be presented with an extra prize while on the 3 Night holiday
10. There is a limit of three entries for each category which an entrant can submit.
11. Participants should keep copies of all photos submitted as entries will not be returned.
12. All entries must include a photo, a name identifying the location and a title, and must identify which category the picture is intended for.
13. Each entry must be appropriate for display and publication online and should not be obscene or indecent. It must not contain defamatory or offensive statements in relation to individuals of a certain race, ethnicity, religion, sexual orientation or socioeconomic group, it must not include threats to any person, place, business or group, it must not invade privacy or other rights of any person or group, and it must not in any other way violate laws and regulations or network standards.
14. Entries must not contain copyrighted works nor contain reference to any third party trademarks or logos.
15. Photos used in entries must not feature **anyone** under the **age of 16** without parental permission.
16. Entrants should ensure that they have the consent of all persons appearing in any photo being entered into this competition.
17. Each entry **must** be the entrant's own work.

18. By entering this competition, entrants grant the following rights;
